CHANGES IN THE PLANNING OF THE TEACHING GUIDE

Content, methodologies, activities, and timing

1. Training activities modality:

External practices may be replaced by:

- The realization of a virtual practical training supervised and recommended by the Coordination of the Master that will be available in the virtual Classroom course corresponding to the External Practices. All the training will be non-face-to-face and will be carried out with the support of the virtual classroom, through the online teaching platform (videoconferences, video viewing, etc.). The training will be included in the Virtual Classroom with a virtual classroom calendar between the months of May, June and July.

- Students may request the evaluation of activities carried out outside the training offered in the virtual classroom and to pass the External Practices, the presentation of practical courses carried out in official organizations, attendance at conferences and congresses, participation with activities in NGOs, work experience in companies , during the academic year 2019-20.

2. Face-to-face or non-face-to-face mode:

Students will be able to pass the External Practices as set out in the Teaching Guide of the subject of the 2019-20 academic year by completing the face-to-face Practices, whenever the confinement situation allows it, even accessing the offer in the month of November 2020. In the same way, they can carry out the External Practices according to the procedure of the approved Guide if it is possible to carry out the work in person in the company.

The way to access the practices offered by companies will follow the methodology indicated by ICARO.

CHANGES IN CRITERIA AND TOOLS FOR THE STUDENTS ASSESSMENT

Ordinary call:

- Training activities modality: use considering the activities carried out before this situation and the virtual attendance once adapted: 75%. Evaluation of the report presented by the student according to the model available on the Master's website and in the Virtual Classroom Course on External Practices: 25%

- Face-to-face or non-face-to-face mode: The form of evaluation of the External Practices carried out in the company face-to-face or not face-to-face will be submitted to the approved evaluation for the 2019-20 academic year.

- In both cases it will be possible to pass the practices in the July or September call (and call extended until December 2020) as long as they comply with the indicated activities and reports.

Extraordinary call:



Whatever the modality (face-to-face or non-face-to-face, or through training activities if it is confirmed that the situation of isolation persists) of the September call (until December 2020), its evaluation will be carried out with the same qualification criteria indicated for the ordinary call.

ADDITIONAL COMMENTS

Changes in resources, infrastructure and other aspects

The extension of the call for the Dissertation until December, is considered an extension of the September call, it is not an extraordinary call. Allowing the student to be able to carry out face-to-face practices in a company following the Icaro offer criteria.
